# CDM - Infrapontem Non-Aggression Pact

---

## I. Mutual Recognition of Sovereignty

1. The Republic of Cortesia Del Mar and The Consulate Of Infrapontem (hereafter “the Parties”) agree to mutually respect the sovereignty and land claims of the other party. Both Parties acknowledge the diplomatic legitimacy of the other.
2. The Parties commit to maintaining peace and stability between themselves, and to resolving any disputes or disagreements which may arise with one another peacefully and respectfully.
3. Pursuant to (2), the Parties shall maintain an avenue of official contact to which the relevant contact points for each Party have access.

## II. Continued Non-Aggression

1. Both Parties agree not to engage in any form of aggression towards one another, defined as–
  - a. military attacks,
  - b. espionage, defined as–
    - i. deliberately entering an unauthorized area marked clearly as non-public via signage or a physical barrier, or
    - ii. deliberately obtaining unauthorized access to confidential internal communications of the other Party, or
  - c. any hostile actions or intentions directed at each other, including on behalf of or through allied nations of each Party.

2. Both Parties agree to remain diplomatically neutral towards one another, including in the event that either Party should—
  - a. form a new alliance; or
  - b. become the object of hostilities by one or more outside groups.Changes to this status are beholden to the same diplomatic processes and negotiations needed to formalize mutual defense and allianceship, wherein there is an establishment of a new treaty or pact.
3. Neither Party may attempt to harm, kill, or pearl the others' citizens without prior negotiation on the matter, unless—
  - a. The individual is on land they are banned from, and this has been communicated clearly to the individual; or
  - b. Such a use of force is necessary to prevent an active crime in progress, and negotiation on the matter is initiated immediately afterward.
4. Neither Party may move the pearl of a citizen of the other Party out of their borders without prior negotiation on the matter. A written agreement to the extradition must be obtained from both Parties prior to extradition.

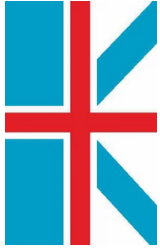
### **III. Ratification, Amendments, and Termination**

1. This Treaty must be ratified by each Party according to its own and any other necessary legal processes, and comes into effect once both Parties have so ratified it.
2. Any changes or amendments to this Treaty must be agreed upon in writing by both Parties. Changes will take effect once both Parties have ratified the amendment.
3. Either Party may terminate this Treaty by giving written notice to the other Party. Such a termination will take effect one week after the notice is given.
  - a. Any violent threat or attempt to free pearls held by the other government will render the non-aggression pact and the terms of this agreement null and void.

### **Appendix I. Dual Nationals**

1. The Parties are absolved of responsibility in terms of this agreement for the actions of individual members with dual nationality in another nation (hereafter "dual nationals") who act on behalf of the other nation, unless—
  - a. the dual national has intentionally used their membership in one Party to avoid consequences for the actions done to the other Party; or
  - b. The actions of the dual nationals are explicitly approved by the government of the Party in which they hold nationality.
2. Dual nationals with membership in one Party whose pearl is held by the other Party are subject to II(4) of this agreement only if the dual national is primarily or habitually associated with the Party with whom they hold membership.
